Retail Food Establishment (over 10,000 sq. ft.)	\$400.00
Temporary Retail Food Establishment	\$ 30.00
Mobile Retail Food Establishment	\$110.00
Catering	\$110.00
Farmers Market	\$ 20.00
Pharmacy	\$ 65.00
Late Fee (renewals only – after January 31 <sup>st</sup> )	Double License Fee
