2019 Novel Coronavirus (COVID-2019) **Weekly Update #56 – December 24, 2020**

Vaccine Planning – What We Know So Far

- The Pfizer vaccine arrived in New Jersey on December 14, 2020.
- The [first COVID-19 vaccine dose was given in New Jersey](#) on December 15, 2020. Vaccinations for frontline healthcare workers at 4 additional NJ hospitals also began this day. As of Friday, December 18, 2020 – a total of 2,149 frontline healthcare workers have received the first dose.
- The Pfizer vaccine is approved for ages 16 and older. The Moderna vaccine is approved for ages 18 and older.
- The vaccine will be rolled out in Phases. The timing of each group will be determined by the vaccine supply.
 - Phase 1A – Healthcare workers in healthcare settings, both paid and unpaid, with direct and indirect contact with infectious secretions.
 - Phase 1B – Essential workers [as defined by CDC](#).
 - Phase 1C – Adults ages 65 and older and those with underlying health conditions.
 - Phase 2 – General Public.
- [Six mega-vaccine sites](#) will open early January 2021. These sites will vaccinate healthcare workers not vaccinated by hospitals.
 - Bergen – Racetrack at Meadowlands, East Rutherford
 - Morris – Rockaway Townsquare Mall, Rockaway
 - Middlesex- NJ Convention & Expo Center, Edison
 - Burlington: Moorestown Mall, Moorestown
 - Gloucester: Rowan College of South Jersey, Sewell
 - Atlantic: Atlantic City Convention Center
- There will be more than 200 vaccine sites at hospitals, federally qualified health centers, urgent care centers, chain pharmacies and other local sites. There are 215 registered to date and more are expected to sign on.
- Long Term Care Facilities (LTCF) will be vaccinated by commercial pharmacies as part of a federal government initiative. Both residents and staff will be vaccinated. This is expected to begin December 28, 2020 starting with veteran's homes and skilled nursing facilities.

- Women who are pregnant and persons who have allergies to vaccines or are immunocompromised should discuss whether to get the vaccine with their primary care providers.
- The most reported [side effects](#) of the vaccine are injection site reaction like redness, warmth and mild swelling. Fatigue, headache and muscle pain has also been reported in some patients.

COVID FAQ Corner

Q: I tested positive for COVID-19 within the last 3 months. If I get exposed to a positive case or travel, do I have to quarantine?

A: At this time, an individual who tested positive for COVID-19 within the last 3 months does not need to quarantine after exposure or travel.

Q: Is the COVID-19 vaccine going to give me COVID-19? I know that's how other vaccines work and I don't want to get sick. I also heard it might alter peoples' DNA.

A: The Pfizer vaccine is an [mRNA vaccine](#). It does not contain the virus. A mRNA vaccine gives instructions to our cells on how to build an immune response and begin making antibodies. The mRNA never enters the nucleus of the cell which is where DNA is. After our cells finish "using the instructions" the cells break down the mRNA.

Q: If a COVID-19 vaccine is coming out why do I still have to wear a mask?

A: All tools that can be used to stop a pandemic should be used including social distancing, mask wearing and vaccinations. We are learning about the COVID-19 vaccination in real time and experts need to understand more about the protection that the COVID-19 vaccine provides before changing recommendations.

New Coronavirus Variant

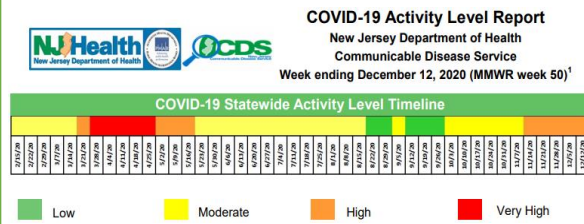
