### **Coadministration of COVID-19 Vaccine with Routine Vaccinations**

The CDC updated clinical guidance on May 14, 2021 to allow COVID-19 vaccines to be administered the same time as other routine vaccines. The American Academy of Pediatrics (AAP) supported coadministration in a [policy statement](#). Previously, COVID vaccines were recommended to be administered alone with a minimum of 14 days before or after administration of other vaccines. Given the importance of routine vaccination and the need for rapid update of COVID-19 vaccines, coadministration of routine immunizations with COVID-19 vaccines (or vaccination in the days before or after) for those behind on or due for immunization is an important tool to prevent disease from spreading within our communities.
